Copyright: AIJRA copyright policy explains the rights associated with publication and distribution of research. It directs how authors, publishers and the wider general public can use, publish and distribute manuscript or books. In order to publish and disseminate research articles, we require publishing rights. This is resolute by a publishing agreement between the author and AIJRA. This agreement deals with the transfer of the copyright to AIJRA and authors hold major rights to employ and share their own published manuscripts. For copyright following steps includes:

Authors sign a publishing agreement where they will have copyright but grant broad publishing and distribution rights to the publisher, including the right to publish the article on AIJRA online platforms. The authors opt for an end user license under which readers can use and share the article. The publisher makes the article accessible online with the author's choice of end user license
